
Dems Unlikely To Hold Senate In 2024 Unless GOP Self-Destructs



GOP Has Slim House Majority

- Current breakdown: 219 Republicans, 213 Democrats and 3 GOP vacancies.
- Last time House flipped during presidential election year was 1952.
- One thing to watch is potential retirements from Congress, which could play a major role in which party maintains control of the House.

Policy Priorities By Issue Area

Budget "Under no circumstances should Republicans vote to cut a single penny from Medicare or Social Security" Cut foreign aid, funds associated with immigration, waste fraud and abuse, IRA climate subsidies Use impoundment to cut spending **Foreign Policy & Defense** "Finish the process of fundamentally reevaluating NATO's purpose and NATO's mission" Seek ceasefire in Ukraine "The greatest threat to Western Civilization today is not Russia. It's probably, more than anything else, ourselves and some of the horrible, U.S.A. hating people that represent us" Request "record" defense spending Taxes Considering cutting corporate tax rate from 21% to 15% Would likely seek a full extension of the 2017 tax cuts (known as TCJA) Repeal the EV credit and potentially other green credits which are seen as benefitting China Repeal the tax increases in Biden's IRA (book minimum tax and stock buybacks excise tax) Trade Enact a universal 10% tariff on imported goods Call upon Congress to pass the Trump Reciprocal Trade Act to give him authority to enact "reciprocal tariffs" to match whatever tariff rates are applied to the US "Higher tariffs will increase incrementally if other countries manipulate their currency or otherwise engage in unfair trading practices" Enforce NAFTA / USMCA provisions more stringently (especially regarding autos) China End most favored nation treatment for China Pursue a 4-year plan to phase out all essential imports from China "Enact aggressive new restrictions on Chinese ownership of any vital infrastructure in the United States, including energy, technology, telecommunications, farmland, natural resources, medical supplies, and other strategic national assets" "President Trump will ban federal contracts for any company that outsources to China"


